ADULT NOMINATION FORM FOR MEMBERSHIP 2024

Each year, upon holding a troop, crew or ship election for youth candidates that result in at least one youth candidate being elected, the unit may nominate eligible registered unit adults (age 21 or over) to the Lodge Adult Selection Committee. The number of adults nominated can be no more than two-thirds (.66) of the number of youth candidates elected, rounded up. Regardless of the two-thirds limit, the unit may nominate the currently-serving unit leader, (but not assistant leaders), as long as they have served as unit leader for at least the previous 12 months. Nominees, with the approval of the Lodge Adviser and Scout Executive, will become candidates for induction, provided all conditions are fulfilled, and be invited to participate fully in an upcoming Ordeal Weekend.

The 15 days and nights must include one, but no more than one, long-term camp consisting of six consecutive days and five nights of resident camping, approved and under the auspices and standards of the BSA. The balance must be overnight, weekend, or other short-term camps. Include above the dates and location of the resident camping experience.
